Qualitative analysis of Criterion 1

G. K. Gujar Memorial Charitable Trust's Dr. Ashok Gujar Technical Institute's Dr. Daulatrao Aher College of Engineering, Karad affiliated with Shivaji University, Kolhapur, adapts to the syllabi under CBCS pattern offered by the university to the respective programmes. The Academic calendar, teaching plan and work plan are prepared by the college and implemented, as per the calendar prepared by the Shivaji University, Kolhapur. It facilitates an academic atmosphere instrumental to the smooth conduct of the programmes. The college conducts cocurricular and extra-curricular activities. The students are involved in creating awareness regarding social issues such as gender, environmental awareness and human rights through different activities. Students are also encouraged to undertake fieldwork and internships. IQAC undertakes curriculum feedback and analyses them and recommends measures for improvement.

All relevant factors related to human values & ethics, gender equality are imbibed. Institute has given equal opportunities to all genders in employment, sports activities, admission and development of their carrier. Institute has given extra care to enhance the soft skills of the students. They have helped faculty members to attend conferences, workshops, seminars etc. However, more initiatives are required to encourage all faculty members for quality publications. College environment for students is conducive to studies with well presence ecology. The college conducts parents-teachers meet, alumni meets once in a year.

Experiential and participative learning methods are practiced in classrooms along with specialized workshops and seminars for enhanced learning. Interactive learning is encouraged with teachers as the facilitator for proper attainment of the outcomes. The use of PowerPoint presentations, Google classroom, blogs and online videos are regular augmentations that enhance the teaching process. There is a mentoring system in place to guide the students to optimal achievements. The college has Continuous Internal Examination system in place. Two unit tests and one model examination in theory and practical are conducted in each semester. In general, the mechanism of internal assessment is transparent and robust in terms of frequency and variety. The college has an academic monitoring committee which monitors day to day activities. The attainment of learning outcomes is calculated using direct and indirect methods. In direct method, performance of student in internal examination and university examination is considered and in indirect method, student progression and placement data is taken into consideration.

Very few faculty members are involved in curriculum development in the university board of studies and many teachers are involved in evaluation process. All examination related greviance redressal mechanisms are online and directly addressed by the students to the university, which is supported by the faculty. Faculties are offering training and skill development programs for the students (e.g. expert lecture, Microsoft company offers training program, workshop, field visit etc.).

The faculty members have very less research projects in the last five years. The college conducted workshops and industrial visits to create awareness of Entrepreneurship among students. Workshops on Intellectual Property Rights have been conducted. Considering the number of total teaching faculty, number of publication during last five years seems to be less. The faculty along with the students work in fulfilling the institution's social responsibility through different extension activities organised by departments or various cells and forums like NCC and NSS. Events like blood donation camp, tree plantation, etc. are organized by the college regularly. Good numbers of students are participating in the extension activities such as Swachh Bharat, Aids awareness, Gender issues etc. The college organized various different extension activities in last five years. The efforts of institute are appreciated and rewarded with some awards for its extension activities in the community. The institute need to apply for external funded research projects.

Significant number of faculty are being supported and motivated for pursuing their Ph.D program (part time) at reputed institutes. Students industry oriented projects are indicative of enabling environment of creativity and innovations. Institute does not offer any Post Graduate course.

The institute has taken progressive steps to provide various infrastructure facilities like up to dated library, Reading rooms, Digitalized language lab, Boys & Girls common room, Gym, Yoga centre, Health care centre and Canteen. The institute has adequate space and facilities for sports, games, cultural activities which include a playground and a good open green campus for the cultural events. There is a playground in the campus which is used for outdoor games like Cricket, Football, Baseball and Basketball. The library is partially automated with e-Granthalaya version 3.0. The registered users can access e-journals, e-books and other electronic resources using N-LIST of INFLIBNET. Institutional resources like previous year question papers, newspaper clippings, e-books and dissertation thesis. Students are given an access to NDL (National Digital Library). The Online Public Access Catalogue (OPAC) facility is there. The Institute has a sufficient computer Laboratories and ICT equipments such as printers and scanners. ICT enable classrooms are sufficiently available to assist academic activities in the institute. The institute procured good number of LCD projectors for ICT enabled Classrooms, seminar halls and laboratories. The institute has internet with 1Gbps fiber optic backbone network with D-link manageable switches supplemented with Wi-Fi support given by few access points. Wi-Fi support for Library is not available. Power supply is ensured by Uninterrupted Power Supplies (UPS) Biometric attendance system is followed for staff members. The college has waste management system in place. As per policy the college has some inhouse staff and on call staff for the maintenance of infrastructure. The overall usage of library by teachers and students can be improved. The college should further improve systems and procedures for maintaining and utilizing physical, academic and support facilities.

The IT facilities in terms of hardware and software are adequate.

The Institute provides platform for financial assistance in the form of various scholarships and freeships. Besides government scholarships, institute gives concession to needy students, provides facility to pay fee in instalments and assistance in the form of industry scholarship. The college has some beneficiary students by scholarships. The statutory bodies like Anti-ragging cell, ICC, Anti-sexual harassment cell, Grievance redressal cell also have the representation of students. The Institute has established Training and Placement Committee that helps students to enhance skills and place in prestigious organizations. Students progress to higher education through succeeding entrance examinations. The Institute provides adequate support to the students for active participation in various activities such as NSS, Annual Gathering, Teachers day, Republic day, Science day, Shivjayanti. The college has a registered Alumni Association which is active and helps college in various ways. However there is no financial support from the alumni, which needs immediate attention.

The G.K. Gujar Memorial Charitable Trust is registered in the year 1995, which played significant role in education of Karad in Maharashtra. They provide the technical education with a reasonable fees where many girl students have taken the admission. IQAC has been established in the institute but needs a lot for its strengthening. The institute has well defined procedure to review teaching learning process, structures and methodologies of operation and learning outcomes at periodic interval through IQAC.

The governing body collects the inputs of the Principal and IQAC while formulating the plan of action of the institution. The Principal, College Council, IQAC and faculty members along with other stakeholders collaborate effectively to fulfil the vision and mission of the institution. The college practices decentralised participatory governance. However there is no financial delegation to the Deans, HOD's etc. The departments prepare an action plan on the academic, curricular and cocurricular activities and the implementation and

planning of the action plan is monitored by the IQAC and college council. The faculty members are encouraged to participate in professional development programmes. The college organises some programmes for professional development and faculty development programmes regularly. There is also a Group Insurance scheme for faculty and staff. The Institution has a transparent and well-planned financial management system and there exists a mechanism of external and internal audit accounts separately. The college has been able to implement of some of the recommendations made by the previous peer team. Feedback from all the stakeholders is taken which can be further improvement. The institute needs to encourage faculty for exposure to reputed institutes

The college conducts various programmes related to gender equity. The college organises various programmes intended to inculcate national values, fundamental duties etc. among the community of the college. Surveillance cameras have been placed across the college campus, including entrance and department corridors. The college has a mechanism for waste management. Rain water harvesting is in place. The college has a lush green campus. A green audit was conducted through an external agency and a green protocol was adopted. College regularly celebrates national festivals and observe days to commemorate national personalities. Republic day and Independence Day are celebrated every year. One of the best practices adopted by the institute is "Student Skill Development Cell" that undertakes various initiatives to enhance student employability. "Environmental Consciousness and Sustainability" is another best practice of the college to foster awareness about the sustainable environment conservation. Distinctive feature of the college is sports that the Institute boasts of being an excellent performance in this field.
